Conduct Code

- Obey and Respect Volunteers and Staff
- Respect Peers
- No Gang Symbols/Activities
- No Profanity, Racial Comments, Loud or Inappropriate Language
- No Fighting
- No Weapons
- No Tobacco, Drugs or Alcohol
 - No Over-The-Counter Drugs
 - Prescription Drugs Require Prior Approval
- No One Under the Influence of Drugs or Alcohol Allowed on Premises
- No PDA (Public Display of Affection)
- No Bare Feet
- No Sitting On Counters, Tables, etc.
- No Standing in Doorways
- No Loitering Outside
- No Drinks / Liquids On Over Near Game Tables
 - One spill can cost Hundreds of Dollars!!!
- One Entry Per Night
- Check In and Sign In Before Entering Building
- Check Out and Sign Out Before Exiting Building
- Clean Up After Yourself
- Return Equipment to Appropriate Place
- Use Equipment As Intended
- Get Permission to Use Phone
- CR8 Not Responsible for Personal Items
 - Don't Take Something That Doesn't Belong to You
 - Store Personal Belongings In Designated Area (coats, jackets, etc.)
- Report any Injuries Immediately
- Report any Damage to Facilities
- Report any Inappropriate Conduct, Language or Touching

Dress Code

- Satanic paraphernalia or implied racist materials or attire are not allowed
- Shoes must be worn at all times. House shoes or wheeled shoes are not allowed. Flip flops and sandals are permitted.
- No low-cut clothing (neck and underarm) will be allowed
- Clothing that exposes the midriff section when arms are to the side or raised will not be permitted
- Halter tops and backless tops are not permitted
- All pants, shorts, skirts must fall at least mid-thigh length when standing
- Clothing must not be tight fitting or excessively loose and baggy.
- Waistlines must be worn at the appropriate position
